

## 2022 IIBEC Document Competition

IIBEC Consultant, Consultant Affiliate, and Quality Assurance Observer members are invited to submit entries for the 2022 Document Competition. Winners will be presented awards at the 2022 IIBEC International Convention and Trade Show at the Rosen Shingle Creek Resort in Orlando, Florida, March 17-22, 2021. Submitted projects must have completed construction after October 31, 2018 and on or before October 30, 2021.

In 2018, IIBEC, introduced the Special Projects Category. Documents can be submitted in this new category, as well as the traditional Large and Small Construction Project categories, and the Report category. Report entries can be any written document pertaining to roofing, waterproofing, or exterior walls, such as survey, forensic analysis, or written peer reviews. Large and Small Construction Project document submissions should include the Project Manual and Drawings. Projects may be for new construction, roof or waterproofing installation, or exterior building envelope renovation design. The Special Projects category recognizes that IIBEC Consultant, Consultant Affiliate, and Quality Assurance Observer members often develop documents that may not fit well into the other project categories. These can include smaller construction projects less than \$250,000 where more unique repair documents are developed, a single unique repair to address a special condition, a more graphical peer review, or any other document type that does not necessarily align with the Report or Large and Small Construction Project categories.

The IIBEC Document Competition Subcommittee will judge the entries for excellence in regard to such criteria as technical merit and organization, with extra points for complexity and application of innovative concepts.

- Thoroughness
- Readability
- Grammar
- Conclusions
- Recommendations
- Complexity (relative to others)
- Technical merit
- Presentation of document
- Overall professionalism

### **Large and Small Projects will be judged based on:**

- Appropriate cost-effective solution
- Technical merit
- Drawing format
- Drawing content
- Specification format
- Specification content
- Complexity (relative to others)
- Thoroughness - limited change orders and problems
- Presentation of document
- Overall professionalism

### **Special Projects will be judged based on:**

- Appropriate cost-effective solution
- Uniqueness of solution
- Technical merit
- Document format
- Presentation of document
- Grammatical composition

- Readability
- Complexity (relative to others)
- Thoroughness
- Overall professionalism

## 2022 IIBEC Document Competition

A maximum total of twelve competition awards will be issued. Prizes may be awarded for first, second, and third place in each of the four categories. Awards include:

Competition award winners will be honored at the upcoming IIBEC Convention. All competition award winners will be on display at the IIBEC Convention. The award winners for each category and place will be identified. Attendance by competition finalists at the convention is encouraged but not mandatory.

## 2022 IIBEC DOCUMENT COMPETITION RULES

1. Competition open to IIBEC Consultant, Consultant Affiliate, and Quality Assurance Observer members only, who acted as the project manager for the document entry.
2. Limited to two entries per person per category.
3. Awards will be made in the name of the entering IIBEC Consultant, Consultant Affiliate, or Quality Assurance Observer member.
4. The committee may elect to not give out 1<sup>st</sup> through 3<sup>rd</sup> place awards in a particular category if there are not deemed to be enough entries meeting the established criteria. In order for an entry to receive an award it must meet minimum criteria established by the document review committee based on a sliding scale using historic evaluation data.
5. A maximum of 10 points can be awarded per judging category with a maximum award of 100 points per entry.
6. All entries and the entry forms must be **submitted on or before October 31, 2021 at 11:59 PM EST** to be considered. Please use the following entry forms or download PDF forms from the IIBEC website at <https://iibec.org/2021-iibec-document-competition/>.
7. There is no fee for entries. Complete an entry form for each entry submitted. Load your submissions at <https://iibec.org/2021-iibec-document-competition/>.
8. Entries become the property of IIBEC and portions may be published in IIBEC *Interface* journal. Submitted materials will not be returned to the entrant.
9. Entries shall be a regular work product funded by fees paid by the client. The work product should include what other coworkers produced in addition to the project manager. Products developed as a marketing tool or as a demonstration are not permitted. Additional enhancement of the document after issuance to the client for the purposes of this competition is not permitted.
10. Entries shall meet the description of the category.
  - A. Reports shall be entirely related to an evaluation or investigation that is directly related to roofing, waterproofing, or exterior walls. Reports shall have been completed and delivered to the client after October 31, 2018 and before October 30, 2021.
  - B. Large and small roofing, waterproofing, and exterior wall construction on the submitted projects must be completed after October 31, 2018 and before October 30, 2021.
  - C. Special projects involving roofing, waterproofing, and exterior wall components shall have been completed or delivered to the client after October 31, 2018 and before October 30, 2021.
11. Entries shall follow submittal package requirements.

- 1.1 **Abstract** (Mandatory -Use attached Abstract form).
- 1.2 **Abstract Attachment(s)** (non-mandatory additional information at the discretion of applicant)
  - A. Text: Maximum one page – 12 point font.
  - B. Graphics: Maximum two pages for drawings, photographs, etc.
  - C. Format:

- 1.4 **Abstract Attachment(s)** (non-mandatory additional information at the discretion of applicant)
  - A. Text: Maximum one page – 12-point font.
  - B. Graphics: Maximum two pages for drawings, photographs, etc.
  - C. Format:
    1. 8½" X 11"
    2. Margins to be 1" right and left
    3. One sided
    4. 24 pound paper, maximum

5. No bindings or covers, one staple in upper left corner

- 1.5 **One (1) document in the complete original format as delivered to the client** (for display at convention).
- 1.6 **One (1) PDF suitable for viewing in Adobe Reader** containing Client's General Conditions, standard forms, and documents created by others (new projects) do not need to be included with submittal copies. If included, add a table of contents referencing these other works.
- 1.7 **Client Authorization, Attachment A** granting permission to the IIBEC Consultant, Consultant Affiliate, or Quality Assurance Observer member to enter the submittal in the competition. ***Please submit client signed authorization with entry by the deadline to avoid elimination from competition.***
